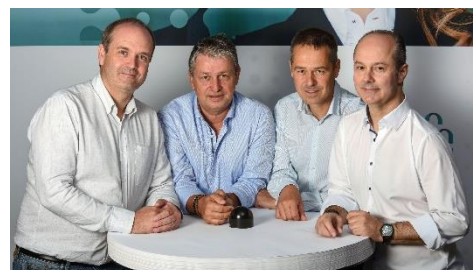
The companies that make up the group retain their independence, and there are no plans for staffing changes in any of the businesses.
